

PERMISSIONS AGREEMENT

This agreement is entered into by and between Dennis V. Damp, copyright holder and author of the works and owner of Bookhaven Press LLC, 249 Field Club Circle, Mckees Rocks, PA 15136; 412-494-6926 ("licensor"), and Name _____, Address _____, City _____, State _____, phone # _____, ("Licensee") to be effective as of ___ day of _____, 20__.

Licensor and Licensee hereby enter into this Permissions Agreement regarding the use of the following articles "Works" written by Dennis V. Damp and titled:

How to be Financially Prepared When You retire ("Licensor's Work")

How to be Physically and Emotionally Prepared When You Retire ("Licensor's Work")

1. **Rights Granted.** Licensor hereby grants to Licensee, its successors and assigns, a non-exclusive license to use the Licensor's Works as provided and in the form provided in the English language, for the term of one year from the effective date of this agreement. No modifications to the articles noted above are permitted except for the inclusion of the "Licensee's" personal data on the top half of page 1 and the inclusion of "Licensee's" contact information on page 3 of Financial article and page 4 of the Physically and Emotionally Prepared article.
2. **Limitations:** Only insurance providers and agents that are actively enrolled and in full compliance with First Annuity's Advanced Federal Marketing Concepts (AFMC) program are permitted to use the Works specified in this agreement. Licensee will supply their personal data and contact information to the Licensor for inclusion in the article to be used by the Licensee. The Licensor will return the final Work with the Licensee's information included in a pdf file delivered via email.
3. **Use of Licensor's Work.** The Licensor's Work shall not be altered, adapted or modified in any manner without the prior written permission of the Licensor, and Licensee shall attribute Licensor's Work as noted in the two articles on page 1 without exception.
4. **Compensation.** In consideration of the rights licensed in this Agreement the Licensee must be an active member and in full compliance with First Annuity's AFMC agreement to use these articles for direct mail pieces, to pass out at seminars, and to give copies to their perspective clients.
5. **Warranties and Indemnity.** The licensor is the sole author of Licensor's Works and sole owner of the rights granted in this Agreement, has not assigned, pledged or otherwise encumbered them and has the right to enter this Agreement and can convey the rights granted to Licensee. Licensor shall indemnify and hold Licensee harmless from any claim, loss or liability arising from a breach of the forgoing warranty. Licensee agrees to indemnify and defend Licensor from any claim, loss or liability arising from Licensee's use of the Licensor's works.
